1. Hard hats must be worn at all times when mounted and no fixed peaks to be worn.
2. Body Protectors must be worn.
3. Any horse/pony which is considered to be unsound, unfit or unhealthy or unsafe by a Judge or the Organiser will be excluded from the competition without refund of entry fee.

**It is the riders' responsibility to ensure that their hat's and body protectors are at the required standard as set out by British Eventing, Pony Club and British Riding Clubs. Baton whips only to be used.**

**OBJECTIONS** ~ Anyone wishing to make an objection must do so in writing within 30 minutes of the incident happening along with a £50 deposit. The deposit will be forfeited if the objection is not sustained.
